Benchmark descriptions: Russell 1000 consists of the 1000 largest companies within the Russell 3000 index. Russell 1000 Value measures the performance of those Russell 1000 companies with lower price-to-book ratios and lower forecasted growth values. Russell 1000 Growth measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values. Russell 2000 measures the performance of the 2000 smallest companies in the R3000, which represents approximately 8% of the total market capitalization of the Russell 3000. Russell 2000 Value measures the performance of those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. Russell 2000 Growth measures the performance of those Russell 2000 companies with higher price-to-book ratios and higher forecasted growth values. Russell 3000 measures the performance of the largest 3000 US companies representing approximately 98% of the investable US equity market. Dow Jones Industrial Average (DJIA) is a price-weighted average of 30 significant stocks. S&P 500 consists of 500 US stocks chosen for market size, liquidity, and industry group representation. Nasdaq Composite includes all common stocks listed on the Nasdaq. The index is mainly used to track technology stocks, so it may not be a good indicator of the market as a whole. MSCI ACWI captures large and mid cap representation across 24 Developed and 21 Emerging Markets countries. With 2,444 constituents, the index covers approximately 84% of the global investable equity opportunity set. MSCI ACWI ex USA captures large and mid cap representation across 23 of 24 Developed Markets countries (excluding the US) and 21 Emerging Markets countries. With 1,842 constituents, the index covers approximately 84% of the global equity opportunity set outside the US. MSCI EAFE (Europe, Australasia, Far East) is a free float-adjusted market capitalization index that is designed to measure developed market equity performance, excluding the US and Canada. MSCI EAFE Small Cap a free float-adjusted market capitalization index that is designed to measure the performance of small capitalization companies in certain developed markets (Europe, Australasia, Far East and excluding US and Canada) and targets 40% of the eligible small cap universe within each industry group, within each country. MSCI defines the small cap universe as all listed securities that have a market capitalization in the range of USD 200-1500 million. MSCI Emerging Markets is a free float-adjusted market capitalization index that is designed to measure equity performance in global emerging markets. Dow Jones US Select REIT measures US publicly traded REIT's and is a subset of the DJ Wilshire Real Estate Securities index. S&P/Citigroup Global REIT measures all real estate investment trusts in both developed and emerging markets. S&P/Citigroup Global ex-US REIT measures all real estate investment trusts in both developed and emerging markets (excluding US). Bloomberg Commodity Index is a rolling commodities index composed of futures contracts on 19 physical commodities traded on US exchanges. Merrill Lynch US 3 month T-bill is an index of public obligations of the US Treasury within maturities of 3 months. The Barclays U.S. Treasury TIPS Index is a subset of the Global Inflation-Linked Index, with a 36.0% market value weight in the index (as of December 2007), but is not eligible for other nominal Treasury or aggregate indices. In order to prevent the erosion of purchasing power, TIPS are indexed to the non-seasonally adjusted Consumer Price Index for All Urban Consumers, or the CPI-U (CPI). Barclays Capital Intermediate US Government/Credit Index is a market value-weighted index of government and investment-grade corporate fixed-rate public debt issues with maturities between one and 10 years. Barclays Capital US Aggregate Bond is a market value weighted index consisting of government bonds, SEC-registered corporate bonds and mortgage-related and asset-backed securities with at least one year to maturity and an outstanding par value of \$150 million or greater. This index is a broad measure of the performance of the investment grade US fixed income market.
